DRAFT PROVISIONAL AGENDA, PLACE AND DATES OF THE SEVENTY-FIRST SESSION OF THE REGIONAL COMMITTEE

1. In accordance with Rule 4 of the Rules of Procedure of the Regional Committee, the Regional Director presents the following proposal on the place and dates for the Seventy-first session of the Regional Committee:

2. By virtue of resolution AFR/RC41/R13, the additional costs of hosting the Regional Committee in a country other than that of the Regional Office shall be fully borne by the host country. Should a Member State be interested in hosting the Regional Committee, an agreement is drawn up between the host country's government and the World Health Organization, covering the following items that are required for the Regional Committee meeting:

- (a) premises, furniture and equipment, including interpretation equipment required for the Regional Committee's work;
- (b) lighting equipment, including maintenance, electric power supply and ventilation of the premises;
- (c) staff for maintenance, cleaning and surveillance of the premises, installations, equipment and supplies;
- (d) postal and telephone service, together with radio and television coverage essential for the efficient and proper coverage of the Regional Committee's proceedings;
- (e) accommodation and travel expenses for the WHO Secretariat authorized to attend the meeting;
- (f) vehicles for transporting Member State representatives, members of the WHO Secretariat, equipment, supplies and documents; national currency at the best rate of exchange and in the amount needed to meet the Organization's expenses in the host country.

3. The Regional Director deems it expedient to draw the attention of the Member States to the need to give full consideration to these commitments.

4. It may be recalled that the Sixty-ninth session of the WHO Regional Committee for Africa, through Decision 4, decided to hold its Seventieth session in Lomé, Togo from 24 to 28 August 2020. However, a physical session was not possible due to the measures put in place in response to the COVID-19 pandemic. Therefore, the Government of Togo has expressed its readiness to host the Seventy-first session of the Regional Committee.

5. It is proposed that the Seventy-first Regional Committee be held from 23 to 27 August 2021. The draft provisional agenda is attached herewith.

6. In accordance with Rule 4 of the Rules of Procedure of the Regional Committee, the Seventieth Regional Committee is invited to consider the draft provisional agenda and determine the dates and place of its next session.
